

Internet Use and Social Media Policy

Audience: School Community

Rationale

The purpose of this policy is to set out guiding principles for the acceptable use of social media by the School Board, students, parents, teachers and non-teaching staff of the St Paul's Anglican Grammar School community, along with protocols for using the internet. It is also intended as a guide to other members of the School Community. This policy covers any negative impact on the School, or its community members, from the unacceptable use of social media. This policy applies to students when students are using any social media at school, at home, during school excursions, camps and extra-curricular activities (where permitted). The policy applies to staff when they are at school, at home, during school excursions, camps and extra-curricular activities, when they are acting in their professional role or not and in all dealings with members of the school community.

This policy does not replace the School's Staff or Student Electronic Communication Policies, but instead complements them. In addition, this policy should be read in conjunction with the ICT Acceptable Use Agreements for staff and students, Junior School - Electronic Devices Guidelines, Junior School Cybersafety Agreement, the Secondary School ICT Acceptable Use Agreement and the Mobile Phone and Other Electronic Devices Policies.

St Paul's Anglican Grammar School believes the teaching of cyber safe and ethical on-line behaviour is essential in the lives of students and is best taught in partnership between home and school.

21st Century students spend increasing amounts of time on-line learning and socialising. These on-line communities need cybercitizens who do the right thing by themselves and others online, particularly when no one is watching.

Social Media – refers to all social networking sites; such as, but not limited to, Facebook, Instagram, Snapchat, TikTok, Twitter, LinkedIn, YouTube, Microsoft Teams, Zoom and Webex.

Rights and Responsibilities

The School community is expected to show respect to others. Members of the School community are also expected to give due respect to the reputation and good name of the School.

When using Social Media, our community is expected to ensure that they:

- Respect the rights and confidentiality of others
- Do not impersonate or falsely represent another person
- Do not bully, intimidate, abuse, harass or threaten others
- Do not make defamatory comments
- Do not use obscene or offensive language towards others
- Do not post content that is hateful, racist, threatening, pornographic or incites violence against others
- Do not harm the reputation and good standing of St Paul's or those within its community
- Do not use excessive criticism to portray a person as socially, mentally, physically or intellectually inferior.

Procedure

A breach of this policy may also involve a breach of other St Paul's policies, such as:

- Electronic Communication Systems Policy
- · Child Safety Code of Conduct
- Staff and Student Professional Boundaries Policy
- Bullying and Harassment Prevention Policy
- Mobile Phone and Other Electronic Devices Policy
- Student Acceptable Use of Digital Technologies Agreements
- St Paul's Staff Code of Conduct
- VIT Code of Conduct

Breaches of policy will be investigated on a case by case basis by the Principal or their delegate, such as the Deputy Principal or Head of School.

All reports of cyber bullying and other social networking misuses will be fully investigated. It is important to note that some online activities are illegal and as such will be reported to the Police. This includes harassment of others and publishing (or in some cases, merely the possession) of inappropriate images.

Students expressly waive any right of privacy in anything they create, store, send or receive on the School's network or any electronic device the student chooses to bring to School. If there are reasonable grounds to believe that Social Media sites may have inappropriate images on them, or if it is believed that any electronic device may have been used to distribute inappropriate material via social media, the device will be confiscated from the student. Depending on the suspected nature of the inappropriate content, staff may request the student to open the phone or provide password access to a computer, tablet or ipad in the presence of the Head of School (and IT staff). A student who has been requested to open a device must comply with this request. If the student does not comply with the request the device will be kept in the possession of the School until the request has been complied with.

Student internet use at school is monitored and regular reports of internet searches are reviewed by Heads of School. Heads of School then identify any Child Safety concerns arising from these reports and act on them according to the Child Safety and other policies of the school. The School also restricts student access to known inappropriate sites and adds to this list as advised.

Sanctions may include, but are not limited to, the loss of computer privileges, detention, suspension or expulsion from the School. Students must be aware that in certain circumstances, where a crime has been committed, they may be subject to a criminal investigation by the Police.

Staff who breach this policy may be suspended or face loss of employment if the breach adversely affects the good reputation of the School and/or it breaches other policies or legislation regarding bullying and harassment. In certain circumstances, where a crime has been committed, they may be subject to a criminal investigation by the Police.

Parents/guardians who breach this policy may be asked to withdraw their child from the School, in cases which adversely reflect on St Paul's or cause harm to members of its community.

Internet and Social Media - Staff Use

This policy addresses the use of social media sites in student learning activities and in teacher and student relationships. The policy also differentiates between online sites available for learning and personal social networking sites.

Online sites available for learning are directly related to achieving School curriculum outcomes such as MyStPauls.

Personal social networking sites are centred on an individual rather than a group and include Facebook, Instagram, Snapchat, TikTok, Twitter, LinkedIn, youTube and other related sites. These types of sites are used primarily for sharing personal information such as photos, videos, updates and chat.

Guiding Principles

- Online behaviour should at all times reflect the School's core values (wisdom, integrity, respect and compassion) and a respect for the dignity of each person, in keeping with the Anglican ethos of the School.
- All School protocol and policy documents must always be observed.
- Staff and student online interaction must only occur in an educational context and on school authorised platforms (e.g school email or MyStPauls).
- Staff and students must behave in an ethical manner when interacting and using online sites available for learning.
- Staff personal social networking must be in accordance with the professional standards expected of a St Paul's teacher or employee and VIT.
- Staff should familiarise themselves with the support provided in school for appropriate use of social media.

Policy

- Staff are encouraged to use online sites available for learning with their students in order to achieve educational outcomes.
- When using online sites available for learning consideration must always be given to the age and developmental level of the students.
- Staff must ensure that they prepare students to act in accordance with the guiding principles before using online sites available for learning.
- The use of any blocked online sites for learning must be approved/authorised by the Head of School, Member of the Executive, e-Learning Co-ordinator or Head of Faculty.
- Parental or carer permission must be obtained for any online sites available for learning which involve community networking or students signing up (and therefore identifying themselves) to join.
- Students must not be asked to falsify their age to register on any site for educational purposes.
- Staff must respect students' rights to privacy when posting comments, marks or work on MyStPauls.
- The learning activity must not be linked back to a student's own personal social networking page.
- Social networking sites such as Facebook, Instagram, Snapchat or TikTok must not be used by staff as learning tools for students.

Procedure to be followed when using online sites for learning

- Discuss any use of online sites for learning which involve community networking with HOF, HOS or e-Learning Co-ordinator outlining the activity and educational goals.
- If usage is not included on the Internet/Netbook Agreement form then school followed by parental permission should be obtained before asking students to register with online community network sites.
- Keep a record of the student's login names (students should not publish their real name on public sites)
- Clearly communicate to students their responsibility for appropriate interaction with others and suitable content posting online.
- Obtain permission from Head of School or relevant School body before posting staff photographs or other identifying photographs online.

- Ensure that your HOF/Curriculum Leader or a member of the Executive has full administrator access to the site.
- Monitor the site frequently and actively review the content.
- Where using internet sites for research or showing video clips (such as YouTube), all sites
 to be browsed or video clips should be checked beforehand to ensure all material
 encountered is acceptable and age-appropriate.

Staff are required to educate students using social media of any kind to:

- Respect themselves and others when publishing or communicating online.
- Keep communication channels transparent and supervised by adults.
- Create a sensible/plain username or identity.
- Keep personal information private.
- Not share usernames and passwords.
- Report any attacks or inappropriate content directed at them.

Staff Personal Social Network Pages

- Social networking sites such as Facebook, Instagram, Snapchat and TikTok etc. must not be used by staff as a platform for learning activities with students.
- Staff should not accept students as 'friends' on their own social network sites or interact with students on social networking sites.
- Staff are advised to use professional discretion before accepting ex-students or parents of current students as friends. They need also to consider carefully on-line interaction with family members who may have school connections.
- Staff must not discuss students or colleagues or publicly criticise school policies or personnel on social networking sites.
- Staff must not post images that include students on social networking sites.
- Appropriate professional standards are required by all St Paul's staff.
